

According to the findings, 55.9% of all students polled knew Tagore was born in Kolkata, and 66.7% of students from Kolkata responded correctly to the same question. 43.9% of students from Kolkata knew May 7th was the great poet's date of birth and 38.7% of all students responded correctly to his date of birth.

Rabindranath Tagore became the first Asian to win the Nobel Prize in 1913, 41% of respondents from Kolkata, and 37.6% of all students answered correctly. Gurudev won the Nobel Prize for his collection of poems, Gitanjali. to the question of which book by him is part of the UNES-CO Collection of Representative Works, 50.2% of all students and 55.25% of students from Kolkata polled responded correctly. The Brainly Knowledge Base has over 10, 000 questions and answers on Rabindranath Tagore. On Gitanjali, some of the insights received from Brainly's Knowledge Base is that the book was originally written in Bangla during 1908-1909 and later its English version in prose was published under
